Founding Merchant Agreement

IMPORTANT: There will never be more than 15 Founding Merchants in the entire history of Infinite Atom Technologies LLC. Read this Agreement carefully. Founding Merchant status is non-transferable and cancellation permanently retires your slot.

// 1. AGREEMENT OVERVIEW

This Founding Merchant Agreement governs the Founding Merchant tier of Infinite Atom Technologies LLC. This Agreement supplements the Partner Terms of Service, which is incorporated herein by reference. In any conflict between this Agreement and the Partner Terms of Service regarding Founding Merchant-specific terms, this Agreement controls.

// 2. THE FOUNDING MERCHANT TIER

2.1 Exclusive Status

A maximum of fifteen (15) Founding Merchant slots will ever be issued in the entire history of the platform. No additional slots will be created under any circumstances regardless of platform growth, ownership changes, acquisition, or business restructuring.

2.2 Benefits

- 30 GB vendor space storage
- Unlimited product listings
- Unlimited product photos
- 0% commission on all sales — Founding Merchants keep 100% of every sale processed through the platform
- Locked subscription rate of \$20.00 per month permanently
- Permanent Founding Merchant badge
- Priority consideration for weekly spotlight rotation
- Input on platform direction as founding community members
- Annual option: \$200/yr locked rate

2.3 Slot Scarcity

Each Founding Merchant slot is permanent. When a slot is vacated through cancellation or termination it is permanently retired and never reopened, reassigned, or resold under any circumstances.

// 3. LOCKED RATE — PERMANENCE & PROTECTIONS

The Founding Merchant subscription rate is permanently locked at \$20.00 per month or \$200.00 per year from the date of this Agreement. This rate will never increase for any reason. This protection:

- Survives platform feature changes and expansion
- Survives changes in payment processor or billing system
- Survives platform ownership changes, acquisitions, and mergers
- Is binding on any successor entity that acquires or operates the Platform
- Cannot be waived or modified by any future agreement without the written consent of the Founding Merchant

The locked rate applies only to the individual or entity named in this Agreement and is non-transferable. If the Founding Merchant cancels, the locked rate is forfeited permanently along with the slot.

// 4. COMMISSION — PERMANENCE

The 0% commission rate on Founding Merchant sales is permanently locked for the duration of the active subscription. This rate:

- Applies to all sales processed through the Platform regardless of future commission changes for other tiers
- Survives platform ownership changes and acquisitions
- Cannot be increased by any successor entity without the written consent of each affected Founding Merchant
- Is forfeited permanently upon cancellation of the Founding Merchant subscription

// 5. NON-TRANSFERABILITY

Founding Merchant status is strictly personal to the individual or business entity named in this Agreement. It may not be sold, transferred, assigned, gifted, or conveyed to any other person or entity under any circumstances including business sale, restructuring, or ownership change. Attempted transfer results in immediate termination without refund.

// 6. CANCELLATION & TERMINATION

6.1 Voluntary Cancellation

You may cancel at any time. Cancellation takes effect at the end of the current billing period. Upon cancellation your Founding Merchant slot is permanently retired. The slot cannot be reinstated, reclaimed, or repurchased under any circumstances once cancelled. No refund is issued for the final billing period.

6.2 Termination for Cause

Infinite Atom may terminate this Agreement for violations of the Partner Terms of Service, Acceptable Use Policy, applicable law, or harmful conduct. Termination for cause results in permanent slot retirement with no refund and no right of reinstatement.

6.3 Platform Shutdown

If the Platform shuts down entirely, Founding Merchants will receive a minimum of 30 days written notice and a prorated refund for any unused portion of a prepaid annual subscription.

6.4 Platform Acquisition

Any successor entity that acquires or operates the Platform is bound by the Founding Merchant rate lock and commission lock for all active Founding Merchant subscriptions. No successor may increase Founding Merchant rates or commissions without the written consent of each affected Founding Merchant.
